General Conditions of Sales – CAMPING DE BOYSE****

COMMON GENERAL CONDITIONS

1. Reserving a pitch is only possible for stays of at least 2 nights. For a shorter stay, you can book by phone or email before your arrival.
2. The reservation only becomes effective after our agreement and after receipt of the duly completed and signed rental contract accompanied by the deposit and reservation fees in the amount of:
 - Pitch: down payment of €60 or the amount of the stay for an amount less than €60
 - Accommodation, Ready to camp, Bivouac or pitch with individual sanitary facilities: down payment of €300 / week started or the entire stay for an amount less than €300

The balance of the rental stay must be paid 30 days before the scheduled arrival date under penalty of cancellation of the rental contract.

3. Upon receipt of the down payment, a confirmation will be sent to you by email or post.
4. The option is maintained for a maximum of 6 days.
5. It is advisable to take out the cancellation insurance offered or the peace of mind option. This is the guarantee of being reimbursed for the sums paid to the campsite in the event of cancellation or interruption of your stay. The cost is :
 - 5% of the cost of the stay excluding tourist tax for cancellation insurance
 - 10% of the cost of the stay excluding tourist tax for the serenity option.

The amount is payable in full upon booking. It is added to the down payment and concerns people registered for the stay. No refund will be made without subscribing to one of these proposals. Conditions are available on request.

6. In the absence of a message (mail, email) specifying that the date of the stay had to be postponed, the rental will become available 24 hours after the arrival date mentioned on the rental contract. You will therefore lose the benefit of your reservation and full payment for the services remains required.
7. The attribution of pitches or mobile homes will be made in the order of confirmed reservations.
8. The reservation is nominative and cannot under any circumstances be transferred or sublet. The number of people mentioned in the contract must not be exceeded, unless agreed with management.
9. In the event of cancellation, no refund will be made by the campsite (cancellation insurance recommended).
10. Minors are only allowed on site accompanied by their parents.
11. Visitors are accepted after agreement with the campsite management by paying a fee and registering at reception. They must park their vehicle outside the campsite. Access to the swimming pool and play areas is prohibited.
12. The swimming pool is not supervised. Only swimsuits are allowed for swimming. Shorts and boxer shorts are prohibited.
13. Charging electric vehicles on the campsite outside the location provided for this purpose is prohibited. The recharging will only be possible after authorization from management and subject to a financial contribution.
14. Taking out Civil Liability insurance is mandatory. The tenant certifies being insured.
15. Our customers are required upon their arrival to read the internal regulations of the campsite and to respect them. Non-compliance may result in expulsion from the campsite without compensation.

SPECIFIC CONDITIONS FOR A PITCH (tent, caravan or motorhome)

1. The reserved pitch is available on the first day of reservation at 2 p.m., occupancy will end on the last day at 12 p.m.
2. Individual sanitary must be vacated by 10 a.m. at the latest on the day of departure.
3. Dogs (tattooed and vaccinated) are allowed in the campsite (2 maximum per pitch) provided they are kept on a leash and do their business outside the campsite. Vaccination record required to be presented upon arrival.

SPECIFIC CONDITIONS FOR ACCOMMODATION

1. Rental requests cannot be less than one week during school holidays unless agreed with management. Each week will begin on Saturday, Sunday or Wednesday from 3 p.m. and end on the following Saturday, Sunday or Wednesday before 10 a.m.
2. A security deposit of €300 will be requested upon your arrival and returned after checking the inventory and cleanliness, less any damage after your departure. Upon your arrival, you are given 24 hours to report any problem in the rental. Cleaning is the responsibility of the tenant, cleaning is not included in the rental price 80€ will be withheld if it does not comply.
3. The balance must be paid 30 days before the scheduled arrival date under penalty of cancellation of the rental contract. No reduction will be granted in the event of delayed arrival or early departure.
4. Provide sheets, pillowcases and household linen if the option to purchase disposable sheets has not been chosen.
5. Animals are allowed in certain accommodations; make sure this is the case for the one you've been allocated. Only tattooed and vaccinated dogs (only 1 per accommodation) are accepted, provided they are kept on a leash and relieve themselves outside the campsite. Vaccination certificate required on arrival.
